RECOMMENDATION

Accept work and authorize recording of a Notice of Completion for the 2020 Street Patching Project, Number 56092.

BACKGROUND

The Council awarded a construction contract on March 18, 2020 to G. Bortolotto & Company for \$152,250 and authorize change orders up to \$20,000 for a total amount of \$172,250. This project consists of grinding and replacing approximately 25,000 square feet of asphalt to a six-inch depth to remediate local pavement failures. This work included all necessary traffic control and involved grinding, sweeping, tack coating, replacing asphalt and finish rolling per Town standard specifications and special provisions. Work under the contract has been completed.

ANALYSIS

The original contract price was for \$152,250. There were no quantity changes.

POLICY ISSUES

There are no significant policy issues related to this item. The item is consistent with the Town's adopted 5-Year Capital Improvement Program.

Measure A Funds in the amount of \$175,000 are budgeted for this project in FY 2019-20. The final cost of this segment of work is \$152,250.
